### **Job Purpose:**

Unitas Youth Zone will provide a holiday club for young people aged 8-12 years old which runs from Monday to Friday (8am to 6pm) during school holidays. As a holiday club worker, your role will be to support and encourage all young people attending the holiday club, to take part in the range of activities and opportunities available to them.

### Context of the post:

OnSide Youth Zones, established in 2008, has been growing rapidly and has ambitious plans to create 100 Youth Zones in towns and cities, giving young people somewhere safe and inspiring to go in their leisure time. Youth Zones are amazing places: accessible, vibrant, welcoming, fun and caring are just some of the words used by young people to describe their Youth Zone. Unitas, opening in Summer 2019, will be no exception, and is part of the OnSide network of Youth Zones.

Many young people, particularly those from socio-economically deprived areas, face an endless maze of boredom, loneliness and temptation, with nowhere to go and a lack of inspiring and productive activities to occupy their leisure time. This can lead to negative impacts on their health, educational attainment and career prospects. These are the young people that will shape the country's future prospects. It is this paradox that lies at the heart of OnSide's drive to establish a national network of Youth Zones; a proven model of youth service provision that is aligned to community needs and supported by cross-sector funding. Youth Zones give young people affordable





access to a broad range of sport, arts and employability services, designed to help them lead active, positive lives and raise their aspirations for themselves and their community.

Unitas Youth Zone is centrally located, dedicated to young people and makes a bold statement about the importance of giving young people high quality places to go in their leisure time. Open 7 days a week including school holidays, the Youth Zone's purpose is to help young people grow to be happy, healthy and successful adults. The state-of-the-art £6.5 million building will provide young people with access to a range of activities, all offering young people the opportunity to try new things, meet new friends and gain support from friendly, warm and positive staff and volunteers. The facilities include a 3G pitch, a gym, sports hall and recreation area, and dance, arts, music and media suites.

- To actively promote the Youth Zone and positively contribute towards increasing Youth Zone membership

- To work alongside other team members and provide guidance and support to young leaders and volunteers
- To undertake to attend regular training and development sessions and events where required
- To contribute and support the youth zones youth work programme
- To encourage young people's participation and engagement in the youth zone programme
- To support and welcome young people into the youth zone, in particular new members
- To promote cultural cohesion and inclusion and proactively challenge any prejudice and discrimination
- To carry out any other reasonable duties as requested by your Line Manager
